TEMPORARY FOOD SERVICE PERMIT APPLICATION

Vermilion County Health Department Temporary Food Service Establishment Permits are required for all temporary food service operations which operate in conjunction with special events open to the public. This includes, but is not limited to, fairs, auctions, special church events, fraternal fund raisers, and special community service events where **FOOD IS SERVED TO THE GENERAL PUBLIC**. Not included are private homes or closed invitation only events such as reunions, wedding receptions, church or fraternal dinners for members only and private parties. School sponsored dinners, prepared at the school, do not require a permit or inspection. Application and fee should be returned to this department.

CLASSIFICATIONS

_____ Class IV – Charity Temporary Establishments are those establishments that request donations without specifying an amount or serve food free of charge. A permit and inspection are required but there is no charge for the permit. **NO FEE**

_____ Class V – Multiple Date Temporary Food Establishments. Please list additional events on back. **FEE \$25.00** for the first event, plus \$10.00 for each additional event.
